INSTRUCTIONS

- 1) Section 1329.01 of the Ohio Revised Code defines a trade name as "a name used in business or trade to designate the business of the user and to which the user asserts a right to exclusive use."
- 2) The filing fee for a trade name registration is \$20.00. Please make checks payable to the Secretary of State.
- 3) If the applicant is a corporation, the registration form must be signed by a corporate officer. If the applicant is a partnership, the registration must be signed by a general partner.
- 4) A trade name registration must be renewed every five years. In addition, if the applicant is a partnership the registration must be renewed whenever there is a change in the listing of the general partners. The renewal filing fee is \$10.00.
- 5) A corporation formed in a state other than Ohio may not register a trade name unless it has obtained a license to transact business in Ohio from the Secretary of State pursuant to Chapter 1703 of the Ohio Revised Code.
