I've been really busy but I'm going to record some books for the kids soon. I've also been thinking lots and I'm going to have to write down some of what I feel so that we can start sorting through some of what happened. I realised a lot of very obvious things that we've never properly discussed and we will need to speak about it all logically eventually. I'm still trying to sort myself out because financially I'm completely fucked. Please listen to me.

For the past six months and before, all my best work went to you and when you kicked me out you told me just to "get a job" you were my only employer and you didn't pay me for my work so I am about to go bankrupt. I was really silly to just trust that I could rely on you in that respect. I thought a lot about what you said about Edmund helping you with the book and how it was only fair you helped him out in return. You also told me that my Schwab articles are by far the most read

out in return. You also told me that my Schwab articles are by far the most read work on UH and except for some NEWSHOUND episodes, all my podcasts and interviews were advertising UH, I wrote 6 articles for your site since January, did podcasts and other stuff and yet I was made to feel like I was scrounging off you. I don't think you treated me with the same respect that you did Edmund in that respect. I was literally living in a form of unpaid servitude while with you, I was relying on you completely, when you broke up with me, you also made me unemployed from a job that paid nothing regardless of how hard I worked for you and how many things I did to help UH. I should never have trusted you when you told me to come back and that I didn't need to worry about finances. Everybody tells me I work for Unlimited Hangout and it makes me really sad that I was accused of trying to rip you off because I asked for £300 to help me out for when I got home and had nothing. I'm amazed you can't understand that.

In regards to Tara, I thought a lot about that too. Although as parents we made a couple of mistakes, we had to be strict and we agreed that because when her father didn't go to her birthday, graduation or Christmas she became really naughty. She had also been naughty for you before I came and while you were without me in America. We were right to be strict/ But to have accused me of being as overbearing as your narcissistic mother was not fair or true. We were right to be strict and we got her back on track. We converted her naughty behaviour into her learning to read and write. Not being allowed to say goodbye to Tara again was horrific psychologically speaking for me. We were best buddies. Yes I was too strict on occasion after her behaviour had improved but that's parenting, I was always looking to protect Tara and I ask you: What would have happened to her at Maria and Jason's that day if I hadn't been there and keeping an eye on her. I am attentive as a parent and I'm not always right, but how you treated me was inhumane. I don't want to argue, and I'm scared of being honest with you because you purposely say nasty and angry things to me. You painted me as being horrible towards Tara and a bad parent, you painted me as a scrounger trying to rip you off while I promote your site and your work with everything I do. I'm scared of talking to you. For very good reason. I feel like I could have predicted this at the start because when we are no longer communicating you instead communicate with someone who hates me and it then spirals.

I made it clear early on that I didn't trust Starr because she hated me and you actually told me that you were having loads of trouble with her and that you were just waiting for the right time to let her go. When you go to someone who hates me to get advice then you'll end up hearing the worst advice eventually. I was documenting his life daily, I don't want to miss out on any of his life. Right now I am. I would tell you how sad this has all made me but my experience I've had from telling you my emotional state makes me not want to. I wish you could feel me again. I was always the one who had to make the effort to connect with you, and when I became depressed, that meant neither of us connected any more. I'm sorry for my part. But I was there trying very hard, I did more than I think you appreciate. Hi John,

Since you declined to read my previous response to your claim that you were unfairly compensated for your work for Unlimited Hangout, I am writing you this email to explain to you how I plan to resolve this unfortunate situation.

Over the last 6 months, when you were living here and all of your living expenses were paid for by me, you were not working Unlimited Hangout full time. You researched, wrote and produced 1 article on the German Marshall Fund and you edited the 5 previously written Black Hand articles, which I published only when the previously intended recipient, UK Column, did not publish them. In that same time frame, you produced 22 videos for your own site and YouTube channels, which have no Unlimited Hangout affiliation.

As far as your claim regarding interviews and podcasts, Unlimited Hangout does not pay authors when they give interviews promoting their work. Iain Davis, John Klyczek and other contributors regularly give podcasts and interviews about their articles published on Unlimited Hangout. It is not part of the compensation. However, you have seem to forgotten that several of these interviews, including on more high-profile outlets like Redacted, were only made possible due to your association with Unlimited Hangout. I had been under the impression that the association with Unlimited Hangout was helpful to you, but you now believe you should have been compensated for interview appearances you were able to book due to your affiliation with the site.

Your Schwab articles (the first one of which I co-wrote and paid and commissioned artwork for - which you continue to use on your personal channels and websites without attribution) were indeed successful. However, the success of Unlimited Hangout preceded their publication and the financial situation of the page was not dramatically affected by the publication of your Schwab series. This is provable thanks to the records of subscriber numbers over time. Other contributors are paid for their articles shortly after publication and there is no agreement, nor has there ever been, with any contributor to receive increased compensation based on article traffic. Many of your articles, aside from the Schwab series, count among the least read on the site, including the Norman Yarvin article and the Black Hand series.

In addition, we had a previous agreement, the messages of which are saved, showing that you agreed to be paid and were paid £1,000 per document you wrote in an effort to help with the book, for a total of £2,000. However, the produced documents were poorly sourced, poorly organized and largely unuseable and, at best, 5 paragraphs in total were used in the final manuscript of the book. It is unreasonable to expect further compensation than what you were already paid, and agreed to receive, for that work.

If you calculate your share of expenses while we lived together, not even counting the expenses of our son, the number of expenses is vastly greater than the amount of money than your Unlimited Hangout articles are worth. Keep in mind that you were paid for all articles prior to us living together and, while we lived together, it was an agreement that we had previously discussed that your articles for the site went toward the costs of living. As noted in the attached documents, the total value of Unlimited Hangout articles published once we began living together are £1,369.35. A gross underestimate of shared living costs, also attached, shows that the amount I spent covering your share of costs was around £17,000 minimum. That does not include the airfare I covered, the equipment/furniture I bought in the UK which you now have, equipment I imported to Chile on your behalf, your doctor's visits in Chile, or – again – any expenses relating to our son.

Given that you feel like your articles for Unlimited Hangout are worth more than £17,000, despite the fact that existing rates for other contributors place it at £1,369.35, I only see one solution for your concerns that you were unfairly compensated. The numbers are so far apart and since it is unlikely we will reach an agreement, I am willing to remove all of your content from Unlimited Hangout per your claims of unfair compensation, so that you can publish all of your articles on your new website. I will make a public statement about removing the content to let people know where that content is now hosted.

As a consequence, you will need to remove Unlimited Hangout from your branding and your bio – on Twitter and elsewhere. You will also need to make it clear that you are not representing Unlimited Hangout in interviews, as you believe you deserve compensation for doing so.

If, after reading this email, you no longer feel that you were unfairly compensated for your work, please let me know. Otherwise, I will be removing your articles, as detailed above, and issuing a statement early next week. Please let me know how you wish to proceed before the coming week.

I sent this to Whitney. We don't have a compensation dispute because I'm not asking for any money. She's using this as a tool to restrict me from seeing my son. I am not interested in speaking with you because of your previous and continued behaviour towards me. This is a relationship dispute between myself and Whitney. I have sent her the message below on Telegram.:

We don't have a compensation dispute Whitney. I was complaining that you called me a scrounger and you've turned it into "compensation dispute". I'm not asking for any money from you. You're painting me as that. I'm clearly stating that our relationship broke down and because I gave all my best work to you and lived of your grace, it left me destitute when you suddenly and without any proper warning kicked me out, and that was very sad for me. I had experienced this exact situation before and you had clearly promised you wouldn't do the same thing again when you convinced me to return to you. You explained that time that you understood that what happened was because you have very clear and obvious scars from experiences in your past in relation to your family. However, you broke the promise you made me and you never addressed that. This is a relationship dispute and you're creating it into an "employment dispute" because you're incapable of communicating directly with me at the moment without being nasty, spiteful and purposely twisting everything I say so as to protect your public image. It's a real shame that you are incapable of trying to communicate with me on a basic level without trying to escalate because your actions stop me from speaking to Rowan regularly. I've been able to talk directly to him once since you began this process of blocking me over and over. You're making this about work but it's not. The same message will be sent to your "assistant" who has played a central role in the breakdown of our relationship. You made it clear to me that she hates me as a person and constantly said bad things about me to you. You blamed her and her advice to you as a main part of the reason that you got so mentally unwell and you promised me that you were looking for a new assistant while you were convincing me that you had changed and I should return to you. I believed you. Now you want me to deal with that person. Stop being obviously silly and start communicating with me without trying to paint me as a scrounger. I'm not asking for any money.

OK, I've read your response and have attached a PDF of screenshots of our previously exchange in an effort to make things more clear. First, I have not restricted access to your son. I offered you money to live and stay in Chile so you could see Rowan every day. You bemoaned the possibility of being "another babysitter" and said it was either living with me or going back to Britain. That was your choice. Then, I blocked you for a week because you wanted to argue constantly. I sent you regular videos of Rowan. Then, at your request, I unblocked you and let you speak to both Rowan and Tara by video call. Afterwards, I said you can call them any time.

That was on a Monday. I heard nothing from you, no requests to talk to rowan, only a message about keeping the weed from getting moldy. Then, on Friday, you sent me this long message about how I had kept you in "unpaid servitude" and had not compensated fairly for your work. You have chosen not to respond to my response to your claims about an alleged lack of compensation. You have now claimed it is about Rowan and that I am restricting access to him. I am not but what I am doing is declining to engage with you in circular arguments where you don't even read the responses you request.

So, unless you state in writing that you were not living in "unpaid servitude" and that you were not uncompensated for your work, I will be removing your content from my site as noted in my previous email.

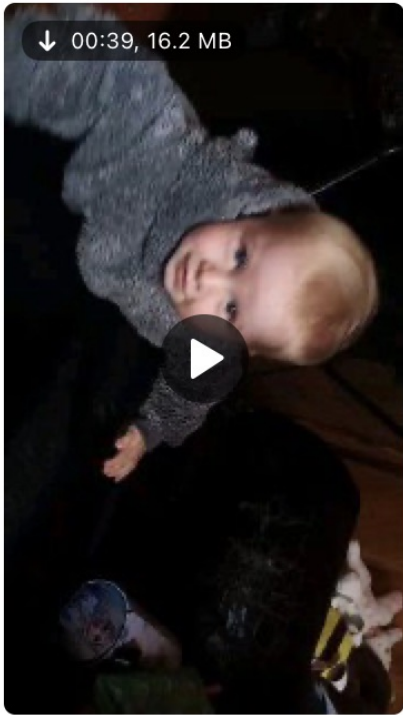

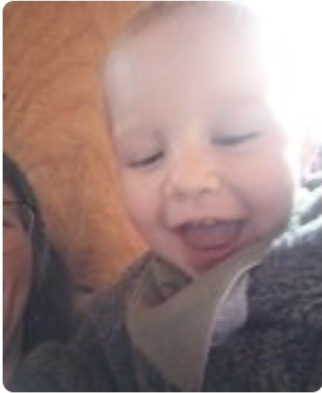

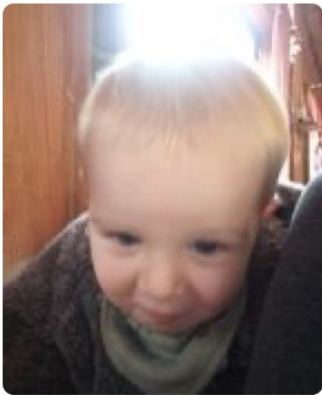

Dear Whitney,

I've been afraid to contact you for many reasons. You've been so angry and hateful towards me and I still don't even understand why we broke up because you had your assistant deal with your break up for you. Every time I called to talk to Rowan you were clearly still very angry and you eventually threatened to delete all my work and attempted to harm my career in multiple ways including starting a spat about a Trans tweet. You must be able to see how unprofessional it was, while at the same time emotionally hurtful, to break up with me and make it all about work. You were going towards doing the same thing you had done with the guy before me, but I'm nothing like him. However much you try to convince me I'm horrible, absolutely everyone I know says differently. I also know why you paint me as horrible because you've told me about your issues in length.

I desperately want regular communication with my son. I miss him beyond belief. He's my boy and I know that what's happened will have broken a large part of the bond we'd formed.

I'm also worried about you because you've told me loads of stuff about the past and I know you really well. You cut people off when you're going towards a crisis. You're soon going to be moving into a new place with the kids and you'll be even more remote and without support. I worry that you're just running away still and that this is not good for your mental health. I have no proper answers from you. You get Starr to deal with it and she tried to break us up for years.

I've received loads of anger from you that has been way beyond normal. I can't even believe some of the things you said to me, no one would, not even you. You cut me off from everyone I'd got to know, and the kids, as well as yourself and it was so horrible to experience. Now I have trouble trusting you. I still can't understand why you couldn't work at it or think about the long term effect that sort of cyclical separation will have on the kids. I don't know why you were so angry. I've seen it four times before and each time you promised it would never happen again.

I don't want my relationship with Rowan to be receiving a few photos every fortnight. But I also worry about some of the things you've told me in the past and have since ignored, especially the fact that you've thought about arranging for the children to go with their fathers and then killing yourself. It does not matter your situation, if you don't sort out the issue at the core of that thought, you will always have the possibility of spiralling. When you go into another relationship, all of this will appear again once situational stress manifests. You do go to pieces once situational pressure is applied, I've seen it throughout our relationship. I want Rowan to be safe and secure and for you to be the same.

There are also other things that I can no longer speak to you about which seriously concern me. I worry that you may be deep into something that I don't properly understand. I really hope that you're a good person, because that's what you sold yourself to be. I would never ever have treated any partner how you treated me at the end. I just would never. I still don't understand.

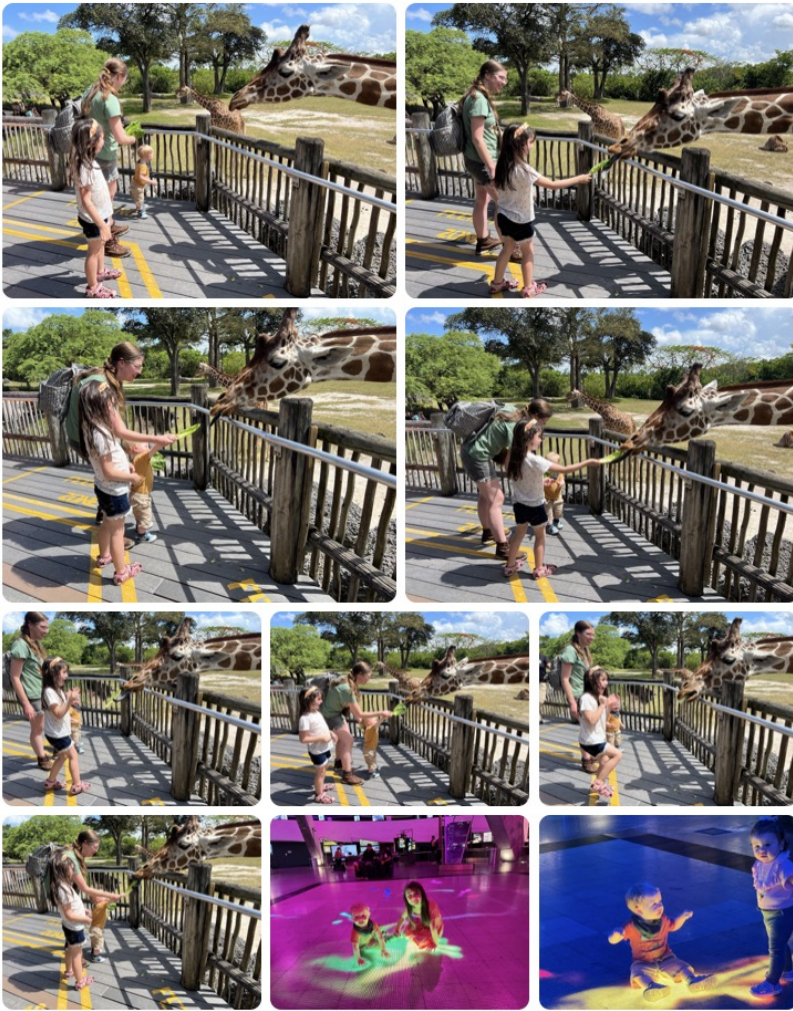



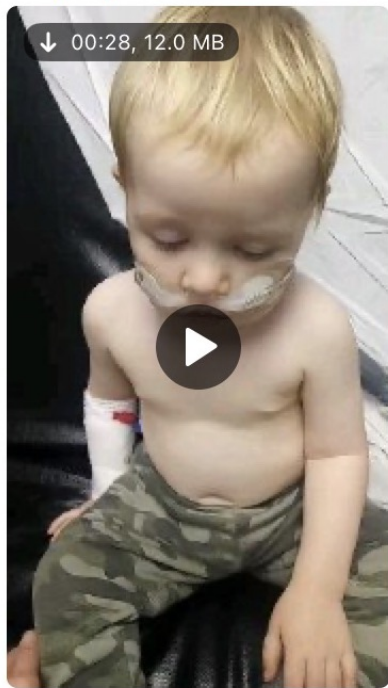

I have been responding to all of your messages just as promptly as telegram. I do not like communicating with you on telegram, it is consistently stressful and is constant bickering and fighting that I do not need. You were unblocked on telegram for over a month and did not ask about your son, most recently you messaged me to complain that I had said that I don't have a professional or personal relationship with you on the UH telegram chat. The telegram channel will post updates as per usual, those updates are frequent and detailed. You are welcome to ask anything else via email and I will tell you if I am unavailable to respond, as I did today.

Why do you have to keep making it about us, court and evidence? Those are really vital questions about Rowan.

If you go back and reread the messages, it is not constantly about that. That happens after we fight incessantly and I explain that I don't think you really have rowans best interest at heart and I don't think it would be safe or good for him to ever live with you if I wasn't around. That remains true. On the occasion that you claim you were a model Father and partner, when I disagree, it has then been an issue of you insisting that my reasons for disagreeing are lies and me saying if that's the case let's take it to court because I can prove it in court and honestly feel that way. Maybe if you didn't repeatedly call me a liar and rewrite the past, it wouldn't come up. Most of the recent arguments have been about that and the record of those same messages show that it is not all me. Most recently, they show me saying I have no information and I don't want to fight and you stating things about the past that were inaccurate and seem designed to coax a response from me about those inaccurate claims, creating a fight.

I asked multiple times before he was ill to speak with him, do you understand that it hurts to know that he's so sick and I haven't been given a chance to speak to him?

Please send the screenshots of the multiple times you asked to speak to him and we're denied. As I recall, over the past month plus, it was one email a week before he was sick and it was not so much a request as a revisionist attempt of you painting my decision to no longer want to live with you and date you as "mental illness." a request to speak to Rowan, which I have repeatedly said you can make at any point and we can arrange it, would instead read something like, " hi, I would like to speak to Rowan tomorrow? What time might you be available?" what you sent could not be farther apart from that.

Who's his doctor?

There are multiple doctors in the pediatric ICU in Temuco. There are about 5 of them and they and the nurses cycle through because it is 24 hour care. If you want to speak to one, you can call the hospital. I gave you the hospital information a few days ago.

How did he get the virus?

I don't know, he and Tara both came down with a cold last Monday and Rowan was fine until late Wednesday /Thursday. I made him a drs appt on Friday morning, he sent Rowan to a physical therapist to get gunk out of his lungs and she sent me to the ER.

How long can he stay sedated like this for safely?

He is expected to be like this 7 to 10 days in total, depending, and that is safe per doctors. The only potential risk is asthma in later childhood.

What are the eventual options?

Eventual options of what? It's not clear what you're asking?

What are we going to choose to do together in various circumstances?

What circumstances? This is too vague to answer?

Explain? It'd be easier to do it in real-time as each update comes in. It'd make me feel a million times better to have a real-time two way conversation about any updates. I'm regards to this statement. I think you have a mental illness because of your behaviour I've observed throughout our relationship which is fully describable and you promised to seek help for. On multiple occasions you said you would sort your issues out and when I returned you broke that promise.

I'm not saying you're mentally ill because of not wanting to live with me. I'm saying it because were exhibiting the same behaviour before I met you. You're last relationship was a public display of ruining someone, do you want to do that with me like you've threatened. I think you should realise that the anger you have towards me was there with both your exes before me. You crash and burn and you tear everything apart.

That behaviour means your erratic and nasty towards me and so I don't get to speak with Rowan. That's why I want you to get help and I still do and you know you need to.

If you fight me publicly instead of giving me access to talk and communicate with Rowan regularly then everything you are tempting to happen will unfold in front of both of us.

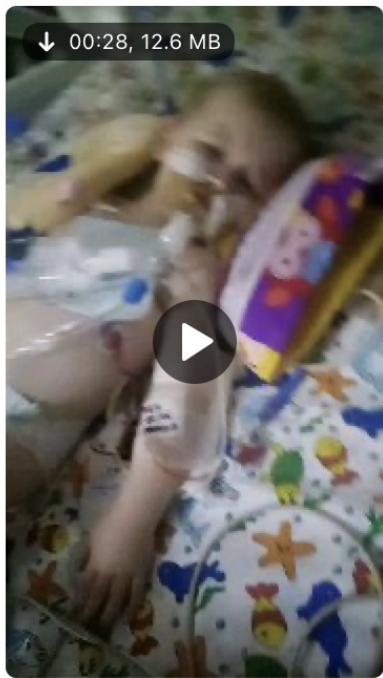

You haven't let me speak to Rowan at all while he's been sick and that's been really hurtful and cruel. Whoever you ask about that will tell you the same. Not letting me communicate or see my sick son in real-time created an environment of toxicity. I just want to have communication with Rowan especially when he's in critical condition.

Telling your fans about my son being in critical condition before telling me was designed to create the toxicity. It's a toxic action and if the roles were reverse I would never have done that to you. Everyone I've spoken to also say it's unspeakably cruel considering the circumstances and I can't believe you've actually told people that you've taken this action.

If a child is in hospital the parents should be working together. Before you told me how sick he was, you told me I didn't really love him. That's the toxic part. I just want to communicate with my sick child and you could be responsible and caring right now. This is the time to get over yourself and your conflict with me and think about what's best for Rowan.

There's no way to spin this. I just want to see and communicate with my sick son in hospital and you won't do what's right. What almost every person you know would do.

As you may recall, the first time you asked to video call rowan during his time in the hospital was after we were here 5 days and only after I had moved things to email because of the dynamic. When that happened you first demanded I unblock you because telegram was faster than email, it later changed to a video call. By that point you were also threatening to report me to the IRS and I did not want to engage. I did subsequently send you pictures of Rowan and provided you with regular updates. Since then you have not emailed, you have been welcome to request pictures, videos or, when he is awake, a video call with him. You have not. Before his hospitalization, when you were not blocked, you did not ask to talk to rowan for well over a month. That was your decision not mine. If you continue to propagate this narrative about how I have handled rowans hospitalization, I will be forced to correct it, as message history (which I have archived) and emails tell a different version of events and I will defend my character if necessary. I have been the one spending every waking moment of the past 5 weeks caring for our son and sleeping by his side and I will not tolerate being defamed while I have sacrificed so much for his well being without you even bothering to ask even once this entire time if there was anything you could do to help or support us. Again, it is only about you and what you want and your needs all of the time.

Whitney. You have to accept what you did. You cut me off from Rowan. I threatened you with the IRS because I was desperate to speak to my son who was in critical condition. I took it back within 12 hours but I was desperate. you have shown zero empathy during this period and yo[u have used Rowan as a tool. You have to act nicely to people if you want them to say nice stuff, and if you're intolerably cruel to someone then they don't say nice stuff.

You made loads of promises about sorting out your mental health to get me to come back to you on the third occasion. You made a load of promises and then you tried for a month, went to America, came back and stopped keeping your promises. You didn't get any support for your mental health and you spiralled. It was so depressing then when you were so nasty and spiteful at the end and then you soon stopped letting me communicate with Rowan. You've threatened to delete all my work and lie about me. All I want is communication with my sick son. The first time that happened was two days ago.

While our son was in critical condition in hospital, you refused to let me speak to him as a way to punish me. All the threats I made came from that sick and cruel decision you took.

All the rest, you don't want to argue about. You are the one who has made multiple public statements about us and me, I haven't.

You stopped me from seeing Rowan when he was in critical condition.

NOT ONE MOTHER OR FATHER ON EARTH WILL SEE THAT FACT AS YOU BEING KIND.

You decide how you act. You told me that you have a support network, but I know that you lie about getting help for what are serious issues surrounding anxiety. We also made a lot of friends together in Chile and you said the worst things to them. If those people are your support structure then you need to tell them the truth. You can;t be the victim when you're the one being vindictive and what you did by stopping me speaking to Rowan while he was in intensive care and in critical condition was the very definition of vindictive.

I only spoke to Rowan for the first time on 20/07/2023. You stopped me speaking to him. Full Stop. Your actions. It was intolerably cruel.

I don't want these conversations anymore. I just want to speak to my sick son while he's in hospital. It is cruel. You not realising that shows that you're not in a good place and no one else is giving you solid advice. Because anyone would have given you that advice, because it's humane.

What you've said about me and Tara's relationship is so hurtful. Tara and I were best buddies again when you kicked me out. I spent storytime at night with us giggling loads. Yes, everyone makes errors when bringing up children but we coordinated together, discussed where we went wrong and used positive energy to change it and focus on her reading and writing and learning her numbers. You completely neglected Tara when you were in the UK, I was constantly being her parent. You told me that yourself, it's written down multiple times. Monkey and I gave Tara loads of attention when you were in Britain and when you left it was sad.

Tara and I had a great relationship, I never hit her or treated her purposely badly. I tried to parent her when she was going out of control, which is something you told me she had been doing lots of before I returned. Her dad didn't turn up for her birthday, graduation and christmas which saw her misbehave for a few weeks and during that time we were both angry with her on occasion because she was naughty. But how you try to paint it as now is not fair.

This is made more sad because I was the one who stopped Tara getting molested while she was just starting to be touched. I had to tell you to go stop what was happening immediately because I'm a really observant parent. You paint me as a monster, but if it wasn't for me Tara would have been molested by an actual monster.

I don't know where you get the 'babysitter' line from.

Your offer to pay for three months rent for me was completely disingenuous. I would have no way to work, feed myself, no income partly because you weren't paying me, no way to move about, and when you offered it you had flipped backwards and forwards threatening to leave me on the street, a threat I have recorded. I couldn't trust someone who was screaming at me, had broken my trust again, and who had already broken all the promises she made to get me to return. So it's such a disingenuous line.

You've made up a load of stuff so that you could give reason to the way you have acted. You did it the first, the second time, the third time and this time too.

I should have realised that getting together with someone who was in the process of publicly devouring their last partner probably wasn't the wisest move.

What I want is for you to sort yourself out and be happy for the sake of the kids. And I want to communicate with my son. The battlefield you're making is mad. I don't want to fight you. I want you to get on with your life. I want you to be in a good place. But you just keep showing your proverbial teeth and creating arguments that you then use as an excuse to stop me speaking to Rowan.

I love Tara, I love Rowan, and I loved you with all my heart. You made me believe that you did, but your actions are like a nightmare for me. I want you to be happy, but you've driven yourself to hide away from people, including me. I'm completely concerned now with the standard of the Chilean healthcare system after they've messed up so much with Rowan. You're hiding. It's clear. Scratch away at it and that's the answer you get. You did it in Cardiff too. I've never seen you really relax with anyone at all. Not one person. You're always tense and you blow up day after day. I got to know you inside and out and I know why you do all of this, you know too.

I don't want to have a petty battle in public like you had with Raul, it certainly won't be good for either of us, and all I've asked from you is to be able to communicate with Rowan, especially when he's sick, and urgently if he's in critical condition. So far you've let me speak to him once in two months a couple of days ago, and while he was in critical condition you used his condition to hurt me because you're in pain.

You need to heal. You've made it clear to me that you've felt no emotion after what happened to you in college, an event which sounds like an MK Ultra program, and that you're desperate to feel again. But in the end, you choose to cut off those who care about you. You need to tackle that ego, because it's going to kill you if you keep doing the same things with every relationship you have.

I want you to be happy, you're not, regardless of whether or not I'm there, and you blame me for the pain in yourself that you will not face so you can eventually heal. I don't want to bicker anymore, I don't want anymore threats, I want to communicate with my sick son and have some idea of when that communication will be happening.
